DISCIPLINARY COMMITTEE - 2023-2024

Objective

To ensure discipline in the campus and to suggest penal measures for students and staff for any kind of violation of discipline. Its objective is also to prevent ragging in the campus.

Aims & Responsibilities

The committee members hear and determine matters related to alleged professional misconduct and/or incompetence against College members. The parties to a hearing are the College and the member who is the subject of the complaint.

Convener of the committee shall convey a meeting of the members and discuss the complaint received from the Director

- i. The Committee may call the candidate to seek an explanation and hear him/her. Explanation shall be taken in writing
- ii. After hearing all the above persons, they shall report their findings in writing, along with punitive action (if any malpractice was detected) to the Director according to the University guidelines/norms
- iii. It is the responsibility of the Discipline Committee to determine if the teacher is guilty of professional misconduct or is incompetent and, if so, to determine and impose the appropriate order.
- iv. The Committee meets thrice a year and as and when the situation demands.
 - First meeting is held prior to the commencement of the Academic Session to decide the distribution of duties & responsibilities to the faculty members for maintaining discipline.
 - The second meeting takes place during mid-session to take actions, if so required.
 - The third meeting is held at a suitable time to discuss and decide about the discipline during conduct of tests and examination.
- The rules of procedure that govern the functioning of the Discipline Committee are made ٧. according to the Statutory Powers Procedure Act and came into effect on October 25, 2012.
- Any other duties the Director / Associate Director may assign. vi.
